

GENERAL TERMS & CONDITIONS FOR THE JOB TO BE EXECUTED:

INSTRUCTIONS TO THE BIDDERS

- 01] Tenderer is required to quote the rates strictly as per the terms and conditions mentioned in the Tender document. Any conditional Tender will not be entertained and will be outright rejected.
- 02] The Tenderer is required to visit the site prior to the submission of bid, to study the actual working condition at the site, & **agency has to submit certificate for site visit, non submission of certificate of site visit will not be considered.**
- 03] Successful Tenderer is required to insure the whole work and their personnel under Workman Compensation Act against any accident, minor and major injuries arising out of the work situation.
- 04] The successful Tenderer shall have to start the work within period of 15 days from the date of receipt of the LOI. In case of non-compliance with the above condition, the contract may be terminated.
- 05] The rate quoted is inclusive of all labor and material required for the work.
- 06] The Scope of work under this Tender is as per plan and design given by site engineer.
- 07] Quantity mentioned in schedule of quantities against each item is only for guidance to quote the rate and no claim will be entertained on either increase or decrease in the quantity.
- 08] Water for the execution and curing will be arranged by the contractor at his own risk & cost. Electricity and water may be supplied for the work at ½ % and 1% of bill amount, if possible at one point. You will have to make your arrangement for its distribution at your risk & cost.
- 09] No escalation in price / rate will be allowed on any ground.
- 10] In absence of detailed specifications, the work should be carried out based on either relevant IS code and /or fair engineering practice.
- 11] All the rates quoted by the Tenderer must be inclusive of all taxes, duties, Royalty, Octroi, transportation, labor, Professional Tax, turn over tax, loading, unloading but Excluding GST.
- 12] All the tenderer must be quote their GST number and Date in the Bid.

- 13] Bidders are requested to quote their rates without GST. GST will be paid/adjusted/reimbursed to the successful bidder as per prevailing rates & rules to the extent directly related to the services rendered or Goods supplied by the successful bidder under the said contract subject to production of documentary proof and bidder will mention the GST amount separately in the invoice/bill along with SAC/HSN code under GST.
Bidders, who are opting for composite scheme under GST, are required to quote their rates inclusive of GST.
- 14] The Tenderer will have to submit 'NO DEMAND CERTIFICATE' along with the final bill of the work, as per the Performa given earlier.
- 15) The quoted rates should hold good for working as per drawings related from time to time.
- 16] In overall interest of project and for better co-ordination Engineers in charge may ask the contractor to stop the work for time being for which no compensation will be paid.
- 17] The contractor shall have to full fill and abide by the provision of labour laws, contract Labour Regulations and Abolition Act, 1970 (Central Act 37 of 1970) pertaining to the employment and labour, Payment of Bonus Act -1965, Payment of wages Act -1936, Payment of minimum wage Act .Over and above contractor will be abide by all laws pertaining to labour as per rules of Government of Gujarat.

General Terms and Conditions of contract Prices.

Prices quoted by the Tenderer should be firm and inclusive of all taxes applicable during the supply period and transportation charges.

1) Payment Terms and Running Bills.;

Invoice should be sent in six copy. [Please mention our LOI/Work Order no in the invoice without fail]. Original invoice, Measurement Sheet Materials Test Certificates if any should be sent to project office in original copy.

MODE OF PAYMENT OF RUNNING BILLS:

- The contractor will submit running bill not less than 2.00 lacks & after duly certified by Civil dept.
- 100% of the bill amount will be sanctioned at Project. On the completion of work the contractor will put final bill duly verified and signed by site in charge which will be passed by project office after,
 - deducting there from :**
 - Income Tax as per the provisions of respective act from time to time.
 - Security Deposit 5% of the bill value.
 - Cost of any services provided by GMDC and/or material supplied by the GMDC.
 - Other deduction either statutory or other work reason, if any.

2) Earnest Money Deposit. / Security Deposit.

- a) The tender must accompany Earnest money deposit Of Rs.4420=00 by demand Draft of Nationalized / Scheduled Bank for the amount as stated above in favor of Gujarat Mineral Development Corporation Limited,. Bank Guarantee will not be accepted.
- b) Earnest money deposit paid as above will be refunded to unsuccessful Tenderer only after finalizing / the corporation makes selection of tender.
- c) Earnest Money / Security deposit will not bear any interest.
- d) EMD paid by the successful Tenderer shall be liable to be forfeited by the corporation, if he does not supply the material as per the required specification, terms and condition of the tender / LOI/Purchase Order/ Work Order.

Tender received without E.M.D. will be outright rejected.

No relaxation on EMD/SD for any small-scale industry shall be considered. EMD will be refunded with in 30 days after finalizing the agency.

3) Work Completion time Schedule :

Work Completion time is the essence of the contract and if Work Completion time is not made as stipulated, corporation shall be at liberty to procure the material at tenderer's risk and cost and if thereby any extra expenditure is involved, the same shall be debited to tenderer's account, If corporation is unable to procure the material from alternate source in time and if corporation suffers any consequential loss, Tenderer will have to bear the same. Corporation in that case will forfeit the EMD and will also have the right to lodge claim against party for damage incurred.

4) Validity :

Validity of the tender should be for 90 days from the date of opening the tender and if required by the corporation, the Tenderer will have to extend the validity for a further period of 30 days.

5) Taxes /GST :

Contractor will have to quote their rate **inclusive all taxes & Excluding GST**. No separate taxes other than quoted rates will be paid. Tenderer are requested to quote rate excluding GST. GST shall be paid /reimburse/adjust to successful tenderer as prevailing rates & rules extent directly related to the service rendered by the successful tenderer under said contract subject to submission of documentary proof and tenderer will mentioned GST amt. separate in bill with SAC/HAS code under GST.

6) Late Delivery / Work Completion time Penalty :

If work is not completed as per work completion time period, time penalty will be levied up to @ 0.1% per day subject to maximum of 10% of contract value.

7) Loss and Damages :

Any loss, damages, or deterioration of the material in transits shall be at the cost of the suppliers. It shall be at the discretion of the corporation to reject, damaged or spoiled material, if so noticed.

8) Approval :


Our decision for acceptance or rejection of the Quality Of work will be final and binding to you.
