

6. Based on Govt. of India notice no. 11013/9/2014-estt. A III on dated 17.3.2020. Govt. of Gujarat has declared an advisory on dated 18.03.2020. vide latter no. circular /Parach-102020501 T on dated 21.03.2020. to restrict spreading of Covid -19 in society 50% staff of class -2to 4 will perform their duty on rotational basis and remain will work from home .

Accordingly Shivrajpur manganese mines has issued circular/ office order to attend alternate day duty to class-2 to 4 employees for avoiding spreading of virus.

Seeing the typical condition of India, Honorable PM had declared 21 days lock down from 24th march 2020 to 14 April 2020. 24:00 to breaking the covid -19 infection cycle.

According to nation lockdown, Shivrajpur manganese mines had called an emergency meeting at project office and decided to release all manpower and only essential staff will perform their duties.

To maintain the Social distance lime marking has been done at crowded place, which is shown below






9. Disinfection of office building & furniture's
