## TERMS AND CONDITION:

1. The sealed tenders should be super scribed with 'Tender for sale of Vehicle' and addressed to the General Manager (Power & M&M), GMDC along with the earnest money of Rs.10,000/- (Rupees Ten Thousand Only) for each vehicle as mentioned above and should be submitted on or before DT.21.09.2020, 17.00 hrs. at Gujarat Mineral Development Corporation Ltd. "khanij Bhavan" , 132 Ft Ring Road, Near University Ground, Vastrapur AHMEDABAD – 380054.

Sealed tenders can also be sent through Post. Tenders received by post will be considered only if the same is received by the GMDC within the stipulated time as given in the Tender Notice and the date of posting shall not be considered as date of receipt of tender form.

2. Eligibility for Participants: The bidders are required to submit documents as per clause no. 3, duly signed & stamped along with required EMD and proof of identification to become eligible for participation in the tender. Any bid not accompanied by requisite EMD and the bid document price shall be summarily rejected.
3. Adhar Card, Driving License/Passport/Voter Identity Card issued by the Election Commission/PAN Card. etc.
4. If the Bid is submitted by a person other than an individual, the details relating to constitution must be specified. If the tender is submitted through Power of Attorney Holder or authorized representative, proof of authorization should be enclosed. The delivery/handing over of the vehicle to the successful bidder will be on proof of valid Identification Card of the successful bidder.
5. Bids will be opened at 5<sup>th</sup> Floor, Conference Room, Corporate office, GMDC, Ahmadabad on DT.22.09.2020 at 15.30 hrs in the presence of Bidders or their representatives who may be present at that time. Only the highest amount quoted for the respective vehicle may be the successful bidder for particular vehicle in tender will be considered for the purpose of deciding the sale of the vehicle.
6. The highest Bidder should pay tendered or bid amount in the form of DD drawn in favour of GMDC, Ahmadabad within 7 days on receipt of the confirmation of sale order from GMDC, failing which the amount of EMD will be forfeited. The successful Bidder will not be allowed to make part payments.
7. While the Bids are opened, unattested corrections if any will be noted by Tender scrutiny committee specifying the number of corrections on each page attesting such corrections. The Bidders should sign with date and initials on pages with unattested corrections noted by the Tender scrutiny committee. The Bidders should quote their rates in annexure - 'B' of tender document both in words and figures. If any discrepancy is noticed in the amount mentioned in figures

and words in the tender schedule, only the highest rate quoted will be considered for evaluation of tenders.

8. The entire set of tender documents should be submitted and no portion should be deleted / detached from the tender documents.
9. Each Bidder should clearly mention his name and postal addresses with pin code. This office will not be held responsible for the non-receipt of information because of incorrect postal addresses furnished in the tender document.
10. Each page of the document should be signed/stamped by the Bidder. The bidders are required to furnish proof of identification as mentioned above and their PAN Number.
11. The Earnest Money Deposit of unsuccessful bidders will be refunded after finalizing the successful bidder who quoted the highest rate for respective vehicle, retaining only the EMD of the first three highest bidders. The EMD of the unsuccessful bidders (whose EMD is retained) will be returned/refunded after receiving full payment from the successful bidder. The EMD of the successful bidder shall be refunded after transfer of vehicle on the name of successful bidder. EMD paid will not bear any interest.
12. Tenders once submitted cannot be withdrawn on any account.

16. The vehicle will be handed over on 'As is where is bases' and 'No complaint' basis and no claim for repair/maintenance etc., will be entertained by the GMDC.
17. GMDC does not give any warranty as to the description, condition or accuracy of details regarding the vehicle given in the schedule and vehicle is sold on "as is where is and what so ever basis ". The Bidder shall be deemed to have satisfied himself on these points including the vehicle offered for sale. No sale shall be invalidated by reasons of any error or default in description thereof in THE

18. The road tax/insurance/passing of vehicle/transfer charges/road fitness charges etc., shall be borne by the successful bidder and GMDC shall not be responsible for the same.
19. GST (as applicable) shall be borne by the successful bidder. (The current rate of GST is 18% for Vehicles above 1200 CC capacity and 12% on less than 1200 CC engine capacity.)
20. In case the finalized successful bidder backs out of the tender process/taking of delivery of the vehicle, the EMD will be forfeited. And next highest bidders will be considered and negotiated for sale of vehicle; the same shall be intimated to them. The terms and conditions regarding forfeiture, deposit of balance amount etc. would be applicable to second highest Bidder also.
21. All Diesel/any other charges, if needed shall be borne by the successful bidder.
22. The successful bidder shall be bound to take the vehicle within 7 days after the settlement of payment/other formalities etc., If for any reason the time is extended by the competent authority, GMDC may levy a ground rent of Rs.100/per day per vehicle and other watch and ward expenses at its discretion.
23. The successful bidder shall be responsible for all formalities, responsibilities due to Sale/transfer/registration/ownership as required by the concerned authorities. However GMDC will assist wherever required in possible manner under prevailing rules.
