5. Bidder registered either in DGS & D, SSI, NSIC or in the Central/ State Govt. or Central / State Govt. undertaking is not exempted by GMDC for paying EMD , SD etc. As well as no price preferences over the quoted rate will be considered.

6. Tender is in two bid system, i.e. Technical Bid and Price Bid. First the Technical bid will be opened .The same will be scrutinized by GMDC and price bid will be opened only for those bidders, who qualify themselves in Technical bid.
7. The bidder is required to quote the rate strictly as per the terms and conditions mentioned in the Tender document. The conditional tender or tender submitted for part items will not be considered and shall be liable for outright rejection. If for any item, rates are not quoted then tender of said bidder may be out rightly rejected. .
8. The tender documents submitted after due date will not be considered for scrutiny and outrightly rejected.
9. The estimated cost of the work is Rs. 1.50 Cr. (Rupees One Crore Fifty Lac) excluding GST at applicable rates.

Further bidders who wish to participate in online tenders will have to procure Digital Certificate as per Information Technology Act, 2000 using which they can sign their electronic bids. Terms and Conditions

1. SCOPE OF WORK

The gallery is to be made at the campus of International Centre of Excellence in Mining Safety and Automation, village Dev Dholera, Ta. Bavla, Dist. Ahmedabad. The Permanent gallery should be installed, operated and maintained by the successful bidder.

It must involve installation and application of Digital display technology such as Holographic projection, Augmented reality or such other technology presenting content related to the legacy of the GMDC.

The concept of the gallery and use of digital technology must highlight history and importance of various minerals, mines and different initiatives of GMDC.

Installation and operation of Inverter of adequate capacity for catering the following needs:

- (i) Public Address System
- (ii) C.C.TV with recording system.

The approximate area of the gallery is 1525 sqft. The bidders must visit the site before submitting the designing concept. As proof of their visit, the bidder must include a certificate from the Centre Head of iCEM certifying their visit.

2. QUALIFICATION CRITERIA

The bidder shall have executed at least one similar work during the period of last 10 years immediately preceding the month in which this tender is uploaded. As a proof, the bidders shall attach copy of work completion certificate, work order/s, bills raised and other relevant documents with tender documents.

3. FINANCIAL CRITERIA

Minimum Annual turnover of the Bidder during any one of the three preceding financial years i.e. 2015-16, 2016-17 and 2017-18 should be at least Rs. 7,00,00,000/- (Rupees Seven Crore only). For this purpose, CA Certificate in original, certifying the turnover for all the stated financial years shall be submitted.

4. TENDER PROCESSING AND EVALUATION:

The selection process will be as under :

- 1) Screening based upon qualification criteria
- 2) Technical evaluation

The selection process would be concept and cost based selection (CCBS). The Evaluation Committee will select the Agency by giving 70% weightage to the concept and designs and 30% weightage on the price bid. Agency with score above 60% in presentation will be qualified for opening of price bid. Agency with below 60% score in presentation will be disqualified

4. The bidders must meet all qualifying criteria. Any bidder not meeting any of the qualification requirements will not be short-listed for the presentation to GMDC for further evaluation.

5. All the bidders meeting qualification criteria are required to present their proposal where they must explain as to what is expected from them. Each bidder will be given a maximum of 10 minutes duration to make the presentation to GMDC broadly based on the following parameters : -

The bidder is required to submit an affidavit in the prescribed proforma regarding genuineness of the documents submitted by the bidder.

5. INSTRUCTIONS TO BIDDERS:

1. All bids (technical and price bid) should be submitted online through the website <https://www.nprocure.com> only. No physical submission of price bid will be entertained as it should be furnished on-line only. Also no fax, e-mail, letters will be entertained for the same.

2. Following should be submitted 'off-line' in sealed covers separately at our Corporate Office, Ahmedabad.(1) Tender Processing Fee, (2) E.M.D. (3) Supporting Documents for Technical Bid

3. Submission of false or incorrect information, history of delayed settlement of claims, reports of unprofessional conduct, among other things, shall be sufficient grounds for disqualification in technical bid.

6. PERFORMANCE SECURITY

The Bidder will be required to furnish the security deposit in the form of Bank Guarantee or Demand Draft for an amount equivalent to 10% of the contract value (excluding taxes). The Demand Draft should be drawn in favor of "Gujarat Mineral Development Corporation Limited" payable at Ahmedabad. If such Performance Security is in the form of a Bank Guarantee, then it should be of any bank approved by Government of Gujarat from time to time except Co-Operative Bank in the form and manner acceptable to the GMDC. The validity of the bank guarantee should be for a period which will be over and above three months after defect liability period. Performance Security should not bear any interest.

7. DISPUTE RESOLUTION AND ARBITRATION

Legal Jurisdiction: Matter relating to any dispute or difference arising out of this agreement and subsequent contract based on the agreement shall be subject to the exclusive jurisdiction of courts at Ahmadabad only.

Dispute Resolution :

“The parties shall endeavour, in the first instance, to resolve any dispute, disagreement or difference arising out of or in connection with this Agreement, including any question regarding its interpretation, performance, existence, validity, termination and the rights and liabilities of the Parties to this Agreement (a “Dispute”) through good faith negotiations.”

“All questions, disputes, differences and/or interpretation of agreement whatsoever, which may at any time arise between the parties to this contract in connection with the contract or any matter arising out of or in relation thereto, shall be referred to Sole Arbitrator as per the provisions of Arbitration and Conciliation Act, 1996 and subsequent amendment thereto. The venue of arbitration proceedings shall be at Ahmedabad. The Language of the Arbitration shall be in English.”

8. NON FULFILLMENT OF THE TERMS & CONDITIONS AND TERMINATION OF THE CONTRACT.

a. if the contractor fails to carry out the work as per the terms and conditions of the contract to the satisfaction of the GMDC, GMDC shall be entitled to forfeit the security deposit paid by the Contractor. This however, shall not absolve the Contractor from his obligation to fulfill the contract. In such event, the GMDC shall have a right to complete and/or to get the work completed at the cost & risk of the Contractor and contractor shall be responsible to pay such cost incurred by the GMDC to complete the work and/or to get the work completed.

b. Likewise, if the contractor does not fulfill the terms and conditions of the contract and does not carry out the work up to the entire satisfaction of the GMDC, GMDC has the right to forthwith terminate the contract as it sole discretion, without assigning any reason, Under such events, the GMDC shall be entitled to forfeit the security deposit paid by the Contractor and the GMDC shall have a right to complete and/or to get the work completed at the cost & risk of the Contractor.

For any reasons, if it is required, the GMDC reserves rights to cancel terminate, amend and/ or alter the contract and / or bifurcate and / or reduce the contract work at any time without giving any notice to the Contractor and without incurring any responsibility. For such cases, Contractor shall have to take away his labour, tools, tackles, machinery, equipment etc. and shall leave the site at once or shall have to carry out the instruction of the GMDC.

9. SUB-CONTRACT

The Contractor shall not assign or sub-contract any portion of this work without the prior written consent of GMDC.

10. QUALITY CHECK & SUPERVISION

The Acceptance / Quality Check shall involve inspection of the entire set, which consist of measurements of infrastructure and other facilities etc. in the presence of the Committee of experts comprising of representative/s of GMDC. The Committee reserves the right to evolve a procedure of quality check to ensure that the end deliverables provided by the bidder are as per the prescribed norms.

11. GMDC's OBLIGATIONS

1. GMDC will provide Room / Hall for the subject work.
2. GMDC will provide all such approvals, permissions and authorizations which the successful bidder may require in connection with execution of the work and the performance of the successful bidder's obligations.
3. GMDC will provide one point of power connection for the said work.
4. GMDC will appoint an authorized person as 'Coordinator' to coordinate with the successful bidder in all matters related to the subject work for the successful execution of the work and to be responsible for all necessary exchange of information required.

12. LIQUIDATED DAMAGES

The time is of essence of this contract.

Liquidated damages will be applicable, on the entire value of the contract.

In case of delay in completion of subject work beyond the date of completion, LD will be applicable at the rate of 0.5% of the contract value for delay of each week subject to maximum of 10% of the contract value. For this purpose, more than three days in a week will be considered as full week. LD shall be recoverable from the the bills payable to the successful bidder under this contract. LD shall not be applicable in case the reason for the delay is not attributable to the successful bidder.

13. CONTRACT PERIOD

The contract period shall be for a period of six months from date of commencement of work.

The successful bidder will operate and maintain the gallery for a period of two years from the date of commencement of operation of gallery.

14. PAYMENT TERMS

On award of the work, the payment for the work will be released as under :

Payment of 50% of the contract value will be released to the successful bidder within one week from the date of acceptance of the work order.

On completion of the work, remaining 50% payment of the contract value will be released.

15. DEFECT LIABILITY

Defect liability period shall be for a period of 12 (twelve) Months from the date of Completion. The successful bidder shall stand guarantee for materials and workmanship. During the defect liability period , if any defect is observed due to materials and or workmanship or from any act or omission of the successful bidder, the successful bidder shall execute all such work of rectification and making good of defects, as may be required by the Co Ordinator, at his own cost and within the time stipulated by the Co Ordinator. The performance security in the form of bank guarantee having validity for a period of three months beyond this 12 months of defect liability period. The successful bidder shall indemnify GMDC against any loss/liability that may be incurred by GMDC on account of any failure on the part of the successful bidder for timely rectification of the defects pointed out within the defect liability period. Performance security will be released only after the defect liability period.

16. Submission of false or incorrect information, history of delaying in completion of work, reports of unprofessional conduct amongst other things shall be sufficient ground for disqualification of technical bid.
