## **1. Purpose of the Document**

GMDC invites bids for the sale of ROM Lignite of Mata-No-Madh Mine through e-Auction conducted on M/s (n) Procure Private Limited. The details of the bidding process, specifications of the lignite and details of the mine are presented in this document.

## **2. About GMDC**

Gujarat Mineral Development Corporation Limited herein after referred to as GMDC, a Government of Gujarat Enterprise, is a pioneer company in the field of mining for more than five decades, catering to the needs of the minerals and solid fuel for the industries based in Gujarat. GMDC's mining activities are spread all over Gujarat. It is currently dealing in minerals like Lignite, Bauxite, Fluorspar, Ball Clay, Silica sand and Manganese. GMDC has also set up a 250 MW lignite based Thermal Power Station at NaniChher in Kutch, Wind power plant of 200 MW at Maliya, Jodiya, Bhanvad, Bada, Varvada, Rojmal and Solar Power Plant of 5 MW at Panandhro Project.

## **3. Location of Mine**

## **4. Specific Terms and Conditions**

### **4.1 Eligibility**

Any Buyer (viz. individual, partnership firm, companies etc.) based in Gujarat – having GST Registration of Gujarat or having lignite consuming unit located in Gujarat (shall submit proof) can participate in e- Auction for procurement of ROM Lignite. Documents required as per Clause 2(b) shall be submitted to GMDC.

### **4.2 Registration**

#### **a) Digital Key and Registration with nProcure (e-Auction M/s (n) Procure Ltd)**

- a. Before participation in the e-Auction, an interested Bidder shall be required to get itself / himself registered with M/s. nProcure Ltd. (herein after referred to as "M/s (n) Procure Ltd"). GMDC Ltd has appointed them to provide all services related to e-auction. Bidders may register themselves as per Annexure -II.

- b. After the registration, all interested Bidder will have a "User ID" & a "password" based on which they can log in. Details of the registration process with the M/s (n) Procure Ltd are attached herewith as Annexure – II.
- c. Only one registration will be done against one PAN number. However, based on more than one independent valid GST registration, more than one registration against a PAN Number can be considered

The interested bidders shall upload scanned documents of following self-certified copy on e-Auction portal (Online) before last date for submission of documents.

Bid Security Amount @ Rs 350/- per MT via DD /NEFT / RTGS (as mentioned in relevant clause) physical copy shall be submitted at corporate office in sealed cover super scribed as "E-Auction for Sale of ROM Lignite from Mata-No-Madh Lignite Mines." by 6 p.m. of last date for submission of documents.
6. Power of Attorney for the authorized person (As per Annexure-I)

In case of bidder being a company, a Power of Attorney for the authorized person of the bidder must be enclosed with Form-A as per format placed at Annexure-I.

In case of bidder being an individual/proprietorship, no authorization would be required.

GMDC reserves unabridged right to examine the original documents, whose copies have been submitted and seek clarification to determine eligibility of bidders to participate in the e-Auction

#### **4.3 Bid Security Amount**

All Buyers having been registered with (n) Procure (M/s (n) Procure Ltd) shall also have to furnish non-interest bearing Bid Security Amount, favoring GMDC, at the rate of Rs.350/- per MT, for their required quantity (Minimum 100 MT and multiple of 100 MT thereafter).

In order to participate in bidding for lots which required Bid Security Amount, the bidder is required to deposit Bid Security amount in advance to avoid any last- minute hiccup. GMDC shall not be responsible for any delay in crediting of the money in the bank account of GMDC Ltd due to any reason.

The bidder shall have to make payment by electronic transfer through RTGS/NEFT in GMDC's Bank Account No. 00062090000855 (IFSC Code- HDFC0000006) HDFC Bank, Navrangpura or in form of DD in favor of GMDC Ltd. payable at Ahmedabad.

#### **4.4 Process of Participation & Bidding in e-Auction:**

- a) After preliminary qualification based on documents submitted by bidders, the auction process will be initiated as per schedule/timeline stated in this document.

- c) After verification of the documents, eligibility shall be decided. GMDC will send the list of eligible bidders to (n) Procure Ltd subject to minimum 03 eligible bidders. GMDC will inform all eligible bidders individually through mail only.
- d) The bidders have to complete the registration process with n Procure Ltd before the tentative date of e-Auction without which bidders cannot participate in e-Auction. However, to avoid inconvenience, bidders are advised to complete the registration process in advance.
- e) The bidders are advised to get themselves acquainted and seek assistance of the e-Auction M/s (n) Procure Ltd- n Procure, before actual e-Auction with respect to system and infrastructure requirement in order to avoid inconvenience or system failure during e-Auction.
- f) Corrigendum:

- g) No separate intimation in respect of corrigendum will be sent to bidder who down loaded the document from the website as information in this respect will not be available to GMDC.
- h) The e-Auction will be for dispatches through trucks arranged by the bidder only.

#### **4.5 Inspection**

Bidders/Customers will be permitted to inspect the ROM lignite at the mine face as per the schedule except on holidays, during the working Hours between 9.00 AM to 4.00 PM. For inspection of the ROM Lignite, interested customers may contact General Manager (Project), Lignite Project Mata-No-Madh.



## 4.6 Auction Methodology

### A. Bidding Process:

- i. The registered Bidders shall be required to record their acceptance after login, of the Terms & Conditions of the e-Auction before participation in the actual Bidding Process.
- ii. Before participating in e-Auction, bidders are to satisfy themselves with the quality of ROM Lignite being offered for sale. The Average Range of the specification of ROM Lignite offered for sale on "As recd. Basis" at GMDC's Laboratory is as under:-
  - Calorific Value (Kcal/kg) – 3000-3500.
  - Fixed Carbon – 15-25% approx.
  - Volatile Matter – 30-35%.
  - Ash Contents – 15-20%.
  - Moisture – 35-40%.
  - Sulphur – 03-04%

Note: The purchaser/ bidder/buyer shall have to satisfy themselves on inspection of the material as to the extent of quality, composition, etc. and make his/her offer accordingly. However, (n) Procure Ltd / GMDC Ltd, do not give any assurance or guarantee that the materials will adhere to specification.

- iii. Prospective Bidders are entitled to Bid for the quantity to the extent of amount of Bid Security, as applicable, which is available with the GMDC at the time of Bidding. The maximum quantity is subjected to a cap of 10000 MT.
- iv. The Bidders while Bidding shall quote their "Bid price" per tonne in Indian Rupee as base price for ROM Lignite price on Ex-Mata-No-Madh lignite mine basis, exclusive of other charges like **Royalty, DMF, NMET, GST, GST Compensation Cess, TCS**, any other charges as applicable at the time of delivery. At the time of lifting/delivery of the material, if there is any change in regard to **Royalty, DMF, NMET, GST, GST Compensation Cess, TCS**, or any other statutory levy, the same will be charged extra to the successful bidder's account.
- v. The Bidder has to Bid for a price above the Floor price to secure consideration in the concerned e-Auction. The Floor price shall be kept the basic price lignite for highest category of customer of Mata-No-Madh Mines at time of e-auction.
- vi. The date, time and period of e-Auction as notified in advance including closing time on portal of (n) Procure Ltd or GMDC Website shall be adhered to but for the event of force majeure. However, the closing time of e-Auction will be automatically extended up to last Bid time, plus 3 minutes, so that opportunity is given to other Bidders for making an improved Bid on that item.

- vii. The bidder shall offer their Bid Price (Per MT) in the increment of Rs.10/= (Rupees ten only) and in multiples of Rs.10/= (Ten only) during the normal e-Auction period and also during the extended period. The minimum quantity increment should be 100 MTs or multiples of 100 MT only.
- viii. While maintaining the secrecy of Bidder's identity, the web site shall register and display on screen the lowest and highest Bid prices of various allotted quantities at that point of time. The system will not allow a Bidder to Bid in excess of his entitled quantity as per the amount corresponding to bid security. However, the bidder may register improved bid at any point of time during the auction.
- ix. Following criteria would be adopted in deciding the successful Bidders:-
  - a. Precedence will be accorded to the highest Bid price in the descending order (H1, H2, H3 and so on) as long as the offered quantity is available for allocation.
  - b. If two or more Bidders Bid the same highest price, precedence for allotment will be accorded to the Bidder who has placed the Bid for the higher quantity.
  - c. In case two or more Bidders Bid the same price and the same quantity, precedence will be given to the Bidders who has accorded his Bid first with reference to time.

**B. Bidding and Buying:**

- a. All bids on the Site are a firm commitment to purchase. If the Bidder is the highest bidder at the end of an auction (meeting the applicable minimum bid or reserve requirements) and bid automatically accepted, the highest bidder may be obligated to complete the transaction with the GMDC. Bids may be increased in price or volume later but may not be withdrawn. Bids cannot be cancelled. All bids must be in Indian Rupees only.
- b. By bidding on an item the bidder agrees to be bound by the conditions of sale/auction included in the item's description (or linked to form the description) so long as those conditions of sale/auction are not in violation of this Agreement or unlawful.
- c. Bidders are strongly advised not to test the auction process with false bids, as it will put Bidder at personal legal risk. It is a crime to use a false name, other false personal information. Willfully entering erroneous or fictitious bids may result in prosecution by M/s (n) Procure Ltd.
- d. M/s (n) Procure Ltd as well as GMDCs' decision on the success or otherwise of a bid shall be final and binding. M/s (n) Procure Ltd as well as GMDC reserves the right to reject or void bids, whether

winning or not, that it deems not to have been made in good faith, or that are restricted or prohibited.

#### **4.7 Post e-Auction process:**

1. Each successful Bidder will be intimated through e-mail / SMS by the M/s (n) Procure Ltd on the same date after the closure of e-Auction. However, it will be the responsibility of the Bidder to personally see and download the result displayed on website, on the same date after close of e-Auction.
2. The successful bidders after the e-Auction will be required to deposit ROM Lignite value **(Basic Lignite Price +statutory duties and other levies)** with GMDC Ltd. strictly as per Clause 4.8 of the terms of payment.
3. Equivalent amount of Bid Security of successful bidder corresponding to successful bid quantity shall be converted into security deposit.
4. **Registration Process as GMDC Customer & Forms, Undertaking:**
  - a. The successful bidder shall have to complete the registration related formalities before payment for delivery order and booking as per normal practice of GMDC.
  - b. Documents as per registration forms and undertaking shall be asked from GMDC at the time of registration from successful bidders.

#### **4.8 Terms of Payment:**

**4.8.1** The ROM Lignite Value for the successful bid quantity to be deposited in advance by the successful bidders for the allotted quantity as per mentioned modality below:

- a) Minimum 30% Bid value for the successful bid quantity of ROM Lignite along with the applicable Royalty, GST, GST Compensation Cess etc. shall be deposited with GMDC Ltd within a period of 7(Seven) working days, after the date of closing of e-Auction.

On receipt of such payment, GMDC Ltd shall issue a LOI/Sale Order to the successful bidders for the total allotted quantity. GMDC Ltd shall also issue a Delivery order for quantity in proportion to the amount deposited. LOI/Sale Order shall be treated as agreement / contract subsequent to e-Auction and always read with/in addition to terms and conditions of this e-Auction document.

The Bid security shall be forfeited by GMDC Ltd on non receipt of the minimum 30% ROM Lignite value within a period of 7(Seven) working day as above.

- b) The balance 70% Bid value or as the case may be for the successful bid quantity of ROM Lignite along with the applicable Royalty, GST, GST Compensation Cess etc. shall be deposited in 02 installments of minimum

30% each to be deposited in such a manner that the last installment is deposited at least 15 days before the last date of lifting of lignite (if the last date is 30th April, the last installment should be deposited by 15th of April). On receipt of each installment payment, separate Delivery orders will be issued for the proportionate quantity only.

If the payment of these installments is not received by last date as above, the balance un-lifted qty. shall be treated as cancelled thereby attracting forfeiture of SD.

Note: - The Total quantity offered in this e-Auction will have to be lifted by the successful bidders on or before Last day..... (45 days from date of issue of LOI) else the SD @Rs.350.00 PMT along with Applicable GST for the un-lifted quantity would be forfeited including but not limited to any other action as may be taken by GMDC Ltd as per provisions of Clause 4.11.

**4.8.2** Bid Security amount shall not be treated as an adjustment towards the ROM Lignite value, but would stand converted into a 'Security Deposit' for performance of the successful bidders towards completion of the said transaction.

**4.8.3** The above security deposit (as converted from the Bid security amount) would be refunded to the successful bidder, after completion of lifting of ROM Lignite, after deducting for any loss or damages caused to GMDC's properties, while lifting the ROM Lignite. However, in the event of default in performance by the successful bidder, the provision of forfeiture of the 'Security Deposit' as stipulated, would be applicable and invoked by GMDC.

**4.8.4** Mode of Payment for Delivery Orders:

The successful bidder shall have to make payment by electronic transfer through RTGS/NEFT in GMDC's Bank Account No. 00062090000855 (IFSC Code-HDFC0000006), HDFC Bank, Navrangpura.

#### **4.9 Procedure of ROM Lignite Delivery**

1. GMDC shall issue separate online Delivery Orders (DOs) to the successful bidders in terms of Clause 4.8 after realization of each payment. The challan issued by GMDC shall indicate destination.
2. The validity period to complete the lifting of the entire sale quantity ROM lignite by road shall be 45 days from the issue of LOI and/or issue date of first DO. ROM Lignite sold, but not lifted within the above specified period will become the property of GMDC and it has the right to sell the unlifted quantity in any manner as GMDC may deem fit without any notice.
3. It is the responsibility of the Successful Bidder to take delivery of the ROM Lignite from the Mine Pit, strictly adhering to the provisions of Mines Act

1952 and the Rules, Regulations, orders and bye laws passed there under. All the applicable laws including the Environment Protection Act shall be abided by the bidder. The loading of the ROM Lignite into the trucks arranged by the Successful Bidder will be done by GMDC and transportation to the Successful Bidder premises shall be the sole responsibility of the buyer only and they shall not give any room for complaint of pollution, whatsoever.

#### **4.10 Refund of Bid Security for Unsuccessful bidders**

The bid security amount shall be refunded by GMDC to the unsuccessful bidders after the completion of e-auction on request being made by them.

#### **4.11 Forfeiture of Bid Security Amount/Security Deposit**

The Bid Security Amount/SD submitted by the successful Bidders will be liable for forfeiture in the following cases:-

- i. The Bid Security shall be forfeited by GMDC Ltd on non receipt of the minimum 30% ROM Lignite value within a period of 7(Seven) working days.
- ii. If the payment of installments as per clause 4.8.1 (b) is not received on the due dates, the balance un-lifted qty. shall be treated as cancelled thereby attracting forfeiture of SD.
- iii. If the successful bidders does not lift the booked quantity within the stipulated validity period, the proportionate Bid Security Amount /Security Deposit @ Rs.350/- per Tonne (as converted from the Bid Security amount) for the un-lifted quantity would be forfeited.

However no forfeiture of SD will be done if the successful bidder lifts at least 90% of the booked quantity. (Say, if the booked quantity is 100 MT and successful bidder lifts 90 MT then SD will not be forfeited. If he lifts only 80 MT then SD for un-lifted quantity of 20 MT, i.e.  $20 \times 350 = \text{Rs } 7000/-$  will be forfeited.)

- iv. If the Successful Bidder fails to lift the booked quantity within the stipulated period due to the reasons attributable to GMDC, then the SD for un-lifted quantity shall be refunded, on request made by the successful bidders.
- v. If the Successful Bidder cancels the order after booking, the Bid Security @ Rs.350/- per MT for the un-lifted quantity shall be forfeited for the cancelled order in similar manner as described in sub clause (iii) above.
- vi. In case of forfeiture of Bid Security, GST shall be deposited by the GMDC and bidder shall not be eligible to claim input tax credit on the GST amount. However, in case of forfeiture of Security deposit amount due to

failure to perform obligations under the terms and conditions of this e-auction, the applicable GST shall be recovered from the bidder and the same shall be deposited by the GMDC.

#### **4.12 Refund of ROM Lignite value**

The value of un-lifted material, if any, shall be refunded after the completion of lifting against the booked quantity under e-auction. However, the said value of un-lifted quantity, after the expiry of the validity period, shall be refunded subject to the completion of required commercial formalities and also subject to forfeiture of SD, if any.

#### **4.13 Royalty, Taxes, Duties and Compensation Cess**

4.13.1 Royalty/GST/Compensation Cess/Tax collection at source or any other taxes/levies/ cess / additional amount as applicable at the time of delivery on the sale of materials covered under this e-Auction shall be borne by the successful bidders. Present Royalty is 6% of the basic price, NMET @ 2% on Royalty, DMFT @ 30% on Royalty, Compensation Cess is Rs.400/- per M.T., Tax Collection at Source (TCS) is 01% of the gross payment received and IGST @ 5.0% for inter-state supplies and CGST and SGST @ 2.5% each for intra-state supplies. TCS -1.0% on total sale value.

4.13.2 At the time of lifting/delivery of the material, if there is any change in regard to Royalty, DMFT, NMET, Compensation Cess, GST, T.C.S. or any other statutory levy, then the same will be charged extra to the Successful bidder's account.

4.13.3 The Bidders should give their bids exclusive of Royalty, All Statutory Charges, Duties, Taxes and any other levies. Such Royalty, Statutory Charges, Duties, Taxes and any other levies as applicable, will have to be paid over and above the quoted rate.

4.13.4 GMDC Ltd. reserves the right to review and change the basic selling price of the successful bidders during validity period of e-auction. In such case, the consent of the successful bidder shall be sought for the changed price. However, there shall not be any forfeiture of Security Deposit on the balance un-lifted quantity if the changed price is not accepted by the successful bidder and the lifted quantity completed prior to changed price shall be treated as final.

### **5. General Terms and Conditions**

**5.1** The ROM Lignite procured under e-Auction is for use within the country and not for Export.

**5.2** All terms and conditions of Scheme are subject to force majeure conditions as applicable.

- 5.3** Bidders must always ensure to keep their email address valid. In any case Bidders cannot be absolved from fulfilling the responsibility of compliance of any of the terms and conditions herein including payment terms due to non-receipt of emails from M/s (n) Procure Ltd/GMDC
- 5.4** Bidders must be extremely careful to avoid any error in bidding (whether typographical or otherwise) and they are fully responsible to check and rectify their bid before submitting their Bid into the live-Auction floor by clicking the "Bid" button
- 5.5** There is no provision for bidding in decimals. The Bidder shall be solely responsible for all consequences arising out of the bid submitted by them (including any wrongful bidding by them) and no complaint/representation will be entertained by M/s (n) Procure Ltd/ GMDC in this regard.
- 5.6** The decision of the Competent Authority of GMDC in matters related to this e-Auction shall be final and binding on the bidders.
- 5.7** Quantity mentioned in notice is only indicative and may undergo a change depending on factors like actual production of ROM Lignite etc.
- 5.8** Notwithstanding anything contained in the auction sale notice or advertisement issued as to description and particulars of material put up for sale, the sale of the ROM Lignite is Ex Mata-No-Madh Mine Face/ surface stockyard on as is where is and no complaint basis only. GMDC do not give any assurance or guarantee that the materials to be delivered will adhere to notice or advertisement or quality/ specification. The bidder shall have to satisfy himself on inspection of the ROM lignite at the mine face as to what they contain and make his/her offer accordingly. No plea of misunderstanding or ignorance of conditions put forth subsequent to any confirmation of sale shall be accepted. The principle of "CAVEAT EMPTOR" (let the buyer be aware) will apply.
- 5.9** There will not be any joint/ third party sampling facility extended to any Successful bidder. Refusal on account of non-suitability and /or sub-standard quality for the allotted quantity of ROM Lignite shall not be acceptable.
- 5.10** GMDC reserves the right to cancel the sale of ROM Lignite under this e-Auction from any source / location in part or whole at any stage at its sole discretion without assigning any reason thereof and no party shall have any right whatsoever to raise any claim in that regard on that count.
- 5.11** GMDC / M/s (n) Procure Ltd reserves their rights to amend/modify/reject the auction deal in full/part and reserves the right to further modify/amend and revise the terms and conditions contained herein in full or in part at any point of time and no party shall have any right, whatsoever to raise any claim in that regard on that count.

- 5.12** Sale under each e-Auction shall be an individual, independent, unique and complete transaction.
- 5.13** GMDC will not be in any way responsible for failure to deliver the materials due to cause beyond their control such as strike, lockout, cessation of work by labourers shortened hours, act of GOD or other causes or other contingencies whatsoever. In eventuality of such events, the contract shall be governed by the provisions of Force Majeure contained in the present document.
- 5.14 CONDUCT DURING DELIVERY:** Successful bidder shall solely be responsible for movement and proper behavior of their deputies, agents, and labourers within GMDC's premises. If any damage caused to GMDC's property, the Successful bidder is responsible to make good such damage to the satisfaction of GMDC, and the decision of GMDC Limited, in this regard shall be final and binding.
- 5.15 STATUTORY AND SAFETY CONDITIONS:** Before commencement of delivery operations, the Successful bidder shall take insurance for the workers under his control, which will not only cover fatal accidents, but also injuries, which may or may not result in partial or permanent disablement. The copy of cover note for insurance shall be submitted in the GMDCL's office.
- 5.16 COMPLIANCE WITH LABOUR LAW AND SAFETY RULES:** During the delivery period, the workers employed by the Successful bidder within the mines premises will be governed by the Labour Laws and Rules, Mine Act 1952, Provision of EPF Act 1951 and GMDC's Security and Safety Rules as applicable.
- 5.17 ACCIDENTS ETC. TO Successful bidder LABOURER / TRANSPORTING MANPOWER:** GMDC will not at any point of time be responsible for any injuries caused to the workers engaged by the Successful bidder due to accident within the Mata-No-Madh Lignite Project premises or at the place of work and the bidder will make transport facility to the accident victims to the hospital and give proper arrangement for medical attention and treatment to his labourers and their representative. The Successful bidder will be solely responsible for any claim arising out of the employment, injuries to labourers in the course of employment under any statute. It is the responsibility of the bidder to provide necessary safety appliances like hand gloves, helmet, boots etc to the labourers who are engaged for handling of the goods.
- 5.18** During delivery, if any of the labourers are found not wearing the proper safety appliances; they will not be permitted to carry out the delivery works and will be sent out of Mata-No-Madh Lignite Project premises. GMDC reserves its right to stop the delivery work, if it is carried out in an unsafe manner.
- 5.19** The entry pass for the men and material has to be obtained from the General Manager, Mata-No-Madh Mine, GMDC or his authorised officer.



- 5.20** The Successful bidder shall observe all statutory and safety measures. The provisions of Mines Act 1952 and the rules, Regulations and orders made there under shall be strictly followed. Further the suggestions/ instructions given by the Mine Manager/Safety Officer/ Assistant Managers or other officials of Mata-No-Madh/GMDC shall be scrupulously followed. All the labours engaged by the buyer must wear safety kits like helmet, shoes, safety belts, gloves, etc. without which the entry is prohibited. The Successful bidder has to make his own arrangements for accommodation and canteen facilities for his workers.
- 5.21 BLACKLISTING:** If it is found that the Successful bidder is not following the terms and conditions of payment/delivery or other conditions of the auction and also indulging in any malpractices either himself or by his agents, deputies or observer, necessary action will be taken as deem fit by GMDC including but not limited to blacklisting of such bidder/buyer/purchaser
- 5.22** No interest will be paid to the purchaser/bidder/buyer on the amount paid or deposited by him and on the amount refundable to him if any.
- 5.23** ROM Lignite in the lot is sold on "as is where is and no complaint basis" from the surface stock yard/ mine faces only. No claim whatsoever shall be entertained on account of loss of weight due to moisture or on quality grounds for the lignite loaded from the stock yard/ faces. The lignite from mine faces or shifted to the stock yard shall be loaded into the trucks of the Successful bidder by the contractor and the weight taken after loading from the stock yard/ mine faces shall be treated as final for the purpose of billing. No guarantee is given as regards to sizes, quality and/or weight.
- 5.24** Removal, loading and transportation of ROM Lignite will be allowed with the specific permission obtained from GMDC's officers authorized by Project Head/ Mata-No-Madh Mine/GMDC. The safety precautions and procedures shall be stringently followed by the Successful Bidder.
- 5.25** The Successful bidder shall report trucks for loading on date and time in coordination with the Project Authority. GMDC may change the delivery time of material depending upon the site conditions. No Delivery of material will be given on holidays observed by GMDC, in general. The delivery may be done on holidays with prior information. The Successful bidder should intimate in writing in advance as to when vehicle will come for taking out the materials. The Lorries authorized by the officer-in-charge of Lignite Sales / Mata-No-Madh Lignite Project alone will be permitted inside the Mine area for loading of the materials. For the entry of vehicles in the Mine area, which is covered in the project area, the statutory obligations like valid driving license, road tax details, brake check up clearance, etc. shall be submitted to the officer authorized by the Project Head/Mata-No-Madh Mine, GMDC and their permission is to be obtained. If the Successful bidder comes without prior written intimation and permission as above, the GMDC Ltd has got the right to return the vehicle without loading and

Successful bidder cannot claim for any loss towards the same. The loaded Lorries shall be permitted to move out of the Mine area, after issue of the Delivery Challan-cum-Gate Pass/Invoice duly signed by the officer authorized by Project Head Mata-No-Madh Mine/GMDC as well as the Security personnel. After loading lignite, if the gross weight is found more than the permitted weight, the vehicle will be sent back for unloading the excess quantity to Stock Yard. If it is less, the vehicle can go for reloading the balance quantity. The spillage lignite from the Truck near the weigh bridges or any other places not earmarked by project authority for loading / unloading / vadh-ghat shall be cleared by the Successful bidder then and there. The empty trucks shall also be fully cleared by the buyer before taking weight; otherwise it will not be permitted for tare weight.

- 5.26** The material will be delivered only to the Successful bidder. If the successful bidder desires to authorize a representative or an agent for delivery, in such case the Successful bidder shall produce suitable power of attorney or authorization letter duly attested by a notary publicly authorizing his representative or agent to lift the materials from GMDC Ltd premises.
- 5.27** Employees of GMDC Ltd /M/s (n) Procure Ltd are not eligible to participate or to represent on any ones behalf in the e-Auction.
- 5.28** Picking the material at random is not allowed. Lifting should be done as a whole without choosing and picking. Only the specified area/mine face identified by the GMDC official will be allowed for lifting. In any case working of the Excavators at the mine face should not be disturbed.
- 5.29** The entire area for this delivery work is under the control of security personnel. The Successful bidder and their authorized person's movement are restricted strictly within the delivery area only. If they are found roaming in other areas of Mata-No-Madh Lignite Project, severe action will be taken not only against them, but, also on the successful bidders/buyers for trespassing.
- 5.30** GMDC will not be liable for any claim and Successful bidder shall keep GMDC fully indemnified and harmless against any claim and proceedings of any of their own or against the employees or other.
- 5.31** In case, the Successful bidder commits any mistake of whatsoever nature due to any reason while bidding during the e-Auction process, no relaxation of any sort shall be entertained by GMDC and action as per terms & conditions of this e-Auction to forfeit the pre-bid Security @ Rs.350.00 PMT for the unlifted quantity in part/full shall invariably be made as the case may be.

**5.32 REVISION OF BID PRICE (PAYABLE PRICE) IN CASE OF REVISION IN NOTIFIED PRICE OF BID GRADE LIGNITE. :**

In case there is revision in basic price of lignite by GMDC, after the auction, the bid price shall be considered equivalent to the revised basic price of the lignite (of the highest grade and category for the mine for which auction has been done) or the original bid price, whichever is higher.

GMDC / M/s (n) Procure Ltd shall have the full liberty to do any or all of the following: - Cancel the contract with immediate effect for the materials under the contract not taken delivery by the successful bidder as on that date, in which case the Pre-Bid Security/Security Deposit and Bid Security along with the balance payment (if paid, any), will stand forfeited.

**5.34** GMDC / M/s (n) Procure Ltd shall have the right to issue addendum to the e-Auction document to clarify, amend, modify, supplement or delete any of the conditions, clauses or items stated. Addendum so issued shall form part of original invitation to e-Auction.

**5.35** The bidder shall have no right to issue addendum to e-Auction document to clarify, amend, modify, supplement or delete any of the conditions or items stated therein.

**5.36 ARBITRATION:** All questions, disputes, differences whatsoever which may at any time arises between the parties to this e-Auction and subsequent contract in connection with the e-Auction and subsequent contract or any matter arising out of or in relation thereto shall be referred to the Sole Arbitrator as per the provisions of Arbitration & Conciliation Act 1996 and subsequent amendment thereto and the venue of the arbitration proceedings shall be at Ahmedabad only. The language of arbitration shall be English only.

**5.37 JURISDICTION:** Matter relating to any dispute and differences arising out of this e-auction process and subsequent contract shall be subject to the exclusive jurisdiction of Courts at Ahmedabad only.

**5.38** In case of any difficulty arises in performing this contracts as per the conditions stipulated therein by any successful bidder, the successful bidder may submit meritorious representation in this regard to MD-GMDC, who after considering will be authorized to take suitable decision including amend/alter the contract conditions/quantities of the works/ extension of the contract period/allotment of additional works/revision of the rates of the work etc.

**5.39 FORCE MAJEURE:**

- a) Force majeure is herein defined as natural phenomena such as floods, drought, earthquakes and epidemics, declaration of war, change in Govt. policies, strikes, lockouts etc. In such conditions of force majeure, both GMDC and successful bidder can claim a force majeure but they are obliged to inform the either party within 10 days in writing on the date of commencing and again ending of the force majeure.
- b) Under the circumstances of force majeure stated above, the contract in terms of period can be extended by period equivalent to the loss of time due to force majeure.
- c) The decision regarding occurrence of force majeure to be considered shall be taken jointly by GMDC and successful bidder.

**5.40 For any dispute arising out of content of this document or Interpretation of any terms thereof, the decision of the GMDC, shall be final and binding upon successful bidder.**

**5.41 INSURANCE:** The successful bidder will be required to ensure Third Party Insurance cover of all their personnel, vehicles employed and deployed throughout the contract period.

**5.42 FORECLOSURE:** If at any time after acceptance of the offer the GMDC shall decide to abandon or foreclose or reduce the scope of the contract for any reason whatsoever and hence not require the whole or any part of the contract to be carried out, GMDC shall give notice in writing to that effect to the successful bidder and successful bidder shall have no claim in respect of any payment of compensation or otherwise whatsoever. In case of foreclosure of contract, the SD or any other amount lying with GMDC shall be refunded to the successful bidder after completing necessary commercial formalities.
